1. Detailed description of goods and/or services

2. Delivery policy

Subject to availability and receipt of payment, requests will be processed within 365 days and delivery confirmed by way of air / ocean freight.

3. Return and Refunds policy

The provision of goods and services by Something Africa Taxidermy is subject to service availability. In cases of unavailability, Something Africa Taxidermy will refund the client in full within 30 days. Cancellation of orders by the client will attract a 50 % administration fee.
